(i) make available to the Malta Stock Exchange at any time upon request, all such information, documentation and/or data as may be necessary for ensuring compliance by the Malta Stock Exchange with its the legal obligations, including but not limited to the Financial Market Act (Chapter 345 of the Laws of Malta), the Prevention of Money Laundering Act (Chapter 373 of the Laws of Malta) and the Prevention of Money Laundering and Funding of Terrorism Regulations; and

(ii) have access to and carry out all such acts as may ne necessary in order to be able to trade on my/our Malta Stock Exchange account/s.

This information may include, but is not limited to:

- A copy of your identification documents (such as your identity card or passport) which shall be sent to the Malta Stock Exchange along with this form
- Information and/or documentation relating to your source of funds or source of wealth.

Your information shall be processed by the Malta Stock Exchange in order to comply with its legal obligations. For the purposes of such processing, the Malta Stock Exchange shall act as controller of your personal data and shall be responsible for ensuring compliance with applicable data protection laws. ## **Glossary of Terms**

| Term                       | Definition   |

| Agent                      | means the person acting for and on behalf of another person when opening an account with the<br>Malta Stock Exchange plc. For the avoidance of doubt, this refers to a situation where the account<br>is opened in the name of the Agent and the Agent is acting on behalf of the Principal when<br>opening the account.   |
| Close Associates           | <ul> <li>means: <ul> <li>a. a natural person known to have joint beneficial ownership of a body corporate or any other form of legal arrangement, or any other close business relations, with that politically exposed person; or</li> <li>b. a natural person who has sole beneficial ownership of a body corporate or any other form of legal arrangement that is known to have been established for the benefit of that politically exposed person.</li> </ul></li></ul>  |
| Immediate Family Members   | includes, but is not limited to:<br>a. the spouse, or a person considered to be equivalent to a spouse;<br>b. the children and their spouses, or persons considered to be equivalent to a spouse; and<br>c. the parents  |
| Member                     | Any member of the Malta Stock Exchange authorised to trade on the account for and on behalf of an account holder via the trading infrastructure operated by the Malta Stock Exchange.  |
| Politically Exposed Person | means natural persons who are or have been entrusted with prominent public functions, other<br>than middle ranking or more junior officials. For the purposes of this definition the term 'natural<br>persons who are or have been entrusted with prominent public functions' includes the following:<br>a. Heads of State, Heads of Government, Ministers, Deputy or Assistant Ministers, and<br>Parliamentary Secretaries;<br>b. Members of Parliament or similar legislative bodies;<br>c. Members of superior, supreme, and constitutional courts or of other high-level judicial bodies<br>whose decisions are not subject to further appeal, except in exceptional circumstances;<br>e. Members of courts of auditors or of the boards of central banks;<br>f. Ambassadors, charges d'affaires and high ranking officers in the armed forces;<br>g. Members of the administrative, management or supervisory boards of State-owned<br>enterprises;<br>h. Anyone exercising a function equivalent to those set out in paragraphs (a) to (f) within an<br>institution of the European Union or any other international body. |
| Principal                  | means the person on behalf of whom the Agent is opening the account with the Malta Stock Exchange plc.   |
| Source of Funds            | means the activity, event, business, occupation or employment from which the funds used in a particular transaction are generated.   |
| Source of Wealth           | means the economic activity which generates the total net worth of the customer.   |
